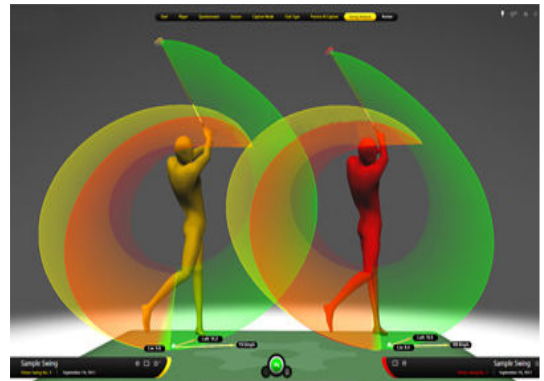

Accommodation at Magnolia Park

We are delighted to announce that we are adding a 30 bedroom hotel to our beautiful golf club and venue and these rooms are expected to be available from late 2014.

The cost of hotel rooms will be around £80 per room including breakfast if the whole hotel is booked, but please contact us for more information and pricing.

Rooms are booked on a first come, first served basis and a non refundable deposit is required to secure the room within 30 days of the initial booking.

For events planned prior to the hotel opening, we can arrange local accommodation for you.



Standard Terms & Conditions

Payment and Deposits

- A non-refundable deposit of 25% is required on confirmation of a booking and payment must be made within two weeks of confirmation to secure the booking.
- Remaining balance will be invoiced and is payable 7 days before the event. Any additional costs incurred on the day of your event will be charged for on the day and must be settled in full at that time.
- All prices quoted include VAT.

Cancellations

In the event of a cancellation the following charges will be made:

- Cancellation of a confirmed booking – loss of deposit.
- Cancellation with less than six months notice – 100% of estimated total charge incl. catering.

Food & Drink

- All wines and drinks are to be purchased from our competitively priced bar and wine list. If you would like to bring your own wine there will be a corkage charge of £8.50 per bottle.
- The wine list will be amended every January and may incur slight increases. The management reserves the right to increase prices without prior notice.
- Children are very welcome at Magnolia Park and our chefs will provide children's menus on request. We also offer a discount on our Inclusive Packages prices for children - prices on application.

Corkage

- No wines or spirits may be brought into the allocated rooms by the Client or guests for consumption on the premises. On certain occasions, products approved by the Magnolia Park may be considered and an appropriate charge levied, by prior arrangement.

Venue Hours & Access

- The venue will be made available for bookings from 9am until 1:20am with the bar shutting at 12:30am, music stopping at 1am and guests departing by 1:20am.
- A bar extension can be requested for an additional cost of £500 until 2am and then guest departure by 2:20am.
- Finishing Times - Events are required to finish at the time agreed when the booking is made and confirmed. Extensions of this time may be chargeable and are at the sole discretion of the Magnolia Park.
- If there is no event on the day before, our customers are welcome to come and set up early. If this is not possible everything can be dropped off at the venue the day before.

General

- Clients are responsible for any table decorations required including place names, seating plan, centre pieces and favours.
- Candles are permitted as table decorations.
- Final numbers for the catering and chair covers are required two weeks prior to the event.
- Smoking is permitted outside Magnolia Park on the terrace or gardens

Damage and Liability:

A charge will be made for any damage or loss of Magnolia Park's fixtures and decorations or to the property including carpets.

Equipment and Storage

Magnolia Park will assist Clients, where reasonably possible, with storage of equipment etc. The Magnolia Park does not accept any liability for loss or damage to any item of equipment.

General Liability

Magnolia Park and Brill Links Sports Management Ltd will not accept liability for any failure to provide the services contracted in the following circumstances:

- a) Industrial action by the Magnolia Park's employees.
- b) Industrial action by the staff of a major supplier.
- c) Fire, lightning, explosion, riot and civil commotion, malicious damage, storm, flood, burst pipes, aircraft impact.
- d) Postal or Electronic bookings which do not reach the Magnolia Park.
- e) Failure of utility companies to supply Magnolia Park with gas, electricity and water services.

Insurance

No responsibility whatsoever is accepted in respect of theft, injury or disease to delegates or guests, nor for loss of damage to property of any kind, less arising as a legal liability for negligence by the Magnolia Park or the employees or Brill Links Sports Management Ltd. Clients should arrange their own insurance for the period of the event.
